Annandale (2006) argues that until recently gender inequalities has tended to be focussed on women but that this is now changing. She argues there is now more research on male health and there is a need for a gender-inclusive approach to women's and men's health.

Evaluate gender inequalities of morbidity and mortality

Over the years ONS research has shown women having a longer life expectancy then men. The common excuse people make is that women live a healthier lifestyle but there is a lot more to it than that.

ONS (2014) statistics showed a much higher death rate in males from heart attacks than in females. This is caused by the boring repetitive manual labour that large numbers of working class males are forced to do. This was argued by Freund et al who further believed that the repetitiveness and general tedious jobs put a strain on them causing them to age a lot faster than females.

However Scambler et al (1981) saw that women had no general interest in visiting the doctor. In her study she found that only 1 out of 11 women visited her doctor first. Most women would either speak to their husbands, female friends, mothers or other relatives about their health problems to find out if their 'condition' is severe enough to visit the doctor.

These statistics are seen to be even worse in men with them often avoiding the doctor when a visit is needed.

ONS (2013) showed 56% of men visit the doctor less than once every five years. Men often see visiting the doctor as diminishing to their masculinity due to the fact weakness is often linked to illness.

Wilkz (1980) who is a feminist argued that women are expected to take care of their bodies much better than men due to the fact they have to take care of children and also during pregnancy and therefore are required to keep a healthy lifestyle for their children while men work.

Dixon (1998) found big gender differences in the health systems employment. While men were mostly taking up doctor and GP employment, nursing and midwifery seemed to be the only job opportunities for women. These areas were mainly dominated by women who were under the control of men.
